

# Final Notice

We have started an investigation of your property.  
Please pay the tax immediately.

**Specified Deadline**

**December 16, 2025**

★ We have repeatedly advised you (your company) to pay the automobile tax (category base), but as of November 14, 2025, we have not been able to confirm your payment.

★ Please pay the tax immediately with the enclosed payment slip.

**If there is no commitment to pay the tax, we will implement a disposition of property (seizure) without notice, in accordance with the provisions of the law.**

## Examples of seized property

<b>Salary and Bonuses</b>	We will inquire with your employer about the amount you are paid and collect the overdue amount from your salary, etc.		
<b>Accounts receivables</b>	We will inquire with your customers about the amount of your accounts receivables and collect the overdue amount from those receivables.	<b>Life insurance</b>	We will seize your right for claiming for payment of cancellation refunds, etc., and collect the overdue amount after forcibly terminating the contract.
<b>Deposits and savings</b>	We will collect the overdue amount from your financial institution's account.	<b>Automobiles, movable property, real estate</b>	We will seize and sell them at a public auction.

## Payment method, etc.

### ① From a smartphone payment app

By using a smartphone app and reading the QR code printed on the payment slip with the smartphone's camera, The payment can be made from the pre-charged balance. For information on available payment apps, please visit the "Local Tax Payment Site" and see the "List of Smartphone Payment Apps."

### ② From the local tax payment website

You can pay your taxes by visiting the Local Tax Payment Website from your computer or smartphone and using a credit card, internet banking, or Pay-easy.

### ③ From financial institutions, post offices, convenience stores, etc.

Please present your payment slip at the counter and make your payment.  
After December 16th, payments will not be possible at convenience stores, etc.

## Late fees

The late fees shown on the payment slip are current **as of December 4, 2025**. Even if the payment is made within the specified deadline, the arrearage may be insufficient depending on the date of payment. If there is a difference between the late fee stated on the invoice and the amount due on the payment date, please pay using the invoice that we will send to you at a later date.
